#### Implementation of New Gate 21 Methodology in the CR

Within a few years, the Healthy Cities Project has become a well-tested support platform for the progress of cities towards local Agendas 21 (LA21), LEHAPs (local environmental health action plans), and other international standards (such as Health 21), recommendations and methods (such as ISO 14000, CP-EMS or PCM-LF).

The methods of New Gate 21 (NG21) are used to prepare the City Health Development Plan (CHDP) that is subsequently incorporated in the City Development Strategy of HCCR. This process facilitates, *among others*, the application of LA21 principles and implementation of LEHAP. The initial effort is to start the process quickly and in the simplest manner possible. The basics of CHDP are, therefore, established in four short team workshops. Then, of course, comes the day-to-day work of coordinators in the Healthy Cities in order to gradually reduce CHDP to practice with the help of local partners (schools, non-governmental organisations) and expert partners (sanitation officers or municipal authority committees).

From the start, the CHDP process receives political backing through a declaration of the city with respect to Health 21, LA21 and LEHAP, approved by the municipal authorities.

By mid 2001, the preparations of CHDPs in the quality of LA21&LEHAP will have been in progress in 23 out of 28 member cities of NSZM CR;

The basics of CHDP based on NG21 methods (LA21&LEHAP) have been prepared in the following cities: **Třebíč, Kroměříž, Zlín, Moravská Třebová, Sedlčany** [5];

The basics of CHDP are being prepared in the following cities:

Brno, Boskovice, Třeboň, Karviná, Orlová, Litoměřice, Valašské Meziříčí, Prostějov, České Budějovice, Hodonín, Blansko [11];

The preparation of CHDP basic version has been launched in the following cities: **Frýdlant n. O., Šternberk, Votice, Poděbrady, Chrudim, Letovice, Veselí n. M.** [7];

A new political declaration pursuant to NG21 to include LA21&LEHAP has so far been adopted by the following cities: **Třebíč, Frýdlant n. O.** [2].

- Charles University Environmental Center works closely with NSZM CR on a series of shows broadcast by Czech Radio from individual member cities;
- In April, the Czech Cleaner Production Centre became the first non-governmental member of NSZM CR;
- Třebíč, a NG21 pilot town, in co-operation with the MS Team managerial agency is preparing a presentation of practical links between the City Health Development Plan and the City Development Strategy at the international WHO conference in Brno;
- At the same conference, the International Institute for Marketing, Communication and Entrepreneurship (IIMCE) will make a presentation of its "Communicating City" program;
- The Institute for Environmental Policy (IEP) offered NSZM CR to participate in the international REC (Regional Environmental Centre for Central and Eastern Europe) project; co-operation in the area of information is being considered;
- The Czech Environmental Institute (ČEÚ) continues to co-operate with NSZM CR in the area of LA21 (comments and suggestions from the autumn meeting of participants interested in LA21, held at the Czech Ministry of Environment, are used and developed), a platform is being prepared for an informational system on LA21 in the Czech Republic; and
- The Veronica Institute (in co-operation with STEP) provided the Healthy Cities with a Czech translation of major European political documents pertaining to sustainable development (among them, the Aarhus Convention or the Lisboa Plan).
